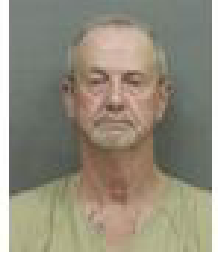

<u>Property Bond</u>	<u>Cash Bond</u>
1. The defendant is required to provide collateral (e.g., property, cash, or a guarantor) to ensure they appear in court.	1. The defendant is required to provide a cash deposit to the court as a guarantee of their appearance.
2. The collateral is held by the court or a third party until the trial concludes.	2. The cash is held by the court until the trial concludes.
3. If the defendant fails to appear, the collateral is forfeited to the court.	3. If the defendant fails to appear, the cash deposit is forfeited to the court.
4. Property bonds are often used for higher-risk defendants or those with significant assets.	4. Cash bonds are typically used for lower-risk defendants or those with liquid assets.
5. The process of obtaining a property bond involves a third party (e.g., a bail bondsman) who provides the collateral on behalf of the defendant.	5. The process of obtaining a cash bond involves the defendant or a family member providing the cash directly to the court.
